



Rover's Run Membership Application



Annual Membership Passes to Rover's Run are issued for a one year period and are valid for 365 days from the date of purchase. It is possible that a membership may be refused if total membership exceeds 500 member limit for the park. Memberships will be sold on a first come, first serve basis.

All members must be at least 18 years of age and present proof of current vaccinations for membership to be considered. Members are responsible for keeping their dog's vaccinations up to date at all times and are responsible for keeping their records with the Greenfield Parks and Recreation Department.

Rover's Run hours are from dawn to dusk-not to exceed 6 am – 10 pm-365 years per year. The Greenfield Parks and Recreation Department, however, reserves the right to close Rover's Run at any time for maintenance or for any other reason deemed appropriate by the Greenfield Parks and Recreation Department.

All dogs must wear a Rover's Run collar tag and it must be visible on the dog when in the park. Each collar tag is \$50.00, \$60.00 for non- residents. Gate access key \$10 additional fee. Each dog must have its' own tag.

Rover's Run Park Fee's & Rules



- 1-Membership tags are required to enter this park.
Tags may be purchased at the Patricia Elmore Center, 280 North Apple Street (317) 477-4340.
Greenfield Resident Fee - \$50 / Non-Greenfield Resident Fee - \$60
Proximity Readers are an additional \$10 for each dog.
- 2-No non-member dogs are allowed in park
- 3-Dogs must wear the park membership tag while inside Rover's Run
- 4-Participating dogs must bear a permanent ID, either a collar tag or a microchip is acceptable
- 5-Dog must have updated vaccinations-The 5 way DHLPP, Rabies and the Bordetella Shot
- 6-Dogs must be at least 4 months of age to receive the required shots
- 7-Dogs must receive heart worm and flea prevention treatment, be free of internal parasites, and be in good health while using Rover's Run
- 8-Vicious, fierce or aggressive behavior(s) is/are prohibited
- 9-Spaying and neutering is required to reduce aggressive behavior
- 10-Everyone is expected to clean up after their dogs by using the waste receptacles provided
- 11-Two dogs per person is maximum limit in Rover's Run
- 12-Children under 11 years of age are prohibited
- 13-Children ages 12-17 years must be accompanied by an adult
- 14-Each dog must be on a leash until they are inside the first entry gate and it is closed-Dogs must be unleashed before they are allowed in Rover's Run
- 15-Excessive barking and digging are not allowed
- 16-Eating people or dog food of any kind inside Rover's Run is strictly prohibited
- 17-Glass containers are not allowed in Rover's Run
- 18-Only dogs are allowed in park-no other animals
- 19-Smoking is not allowed in Rover's Run Park
- 20-The agility equipment, when available, is for dog's use only

Rover's Run Waiver Release & Indemnification Agreement



I (we) agree to hold the City of Greenfield, the Greenfield Parks and Recreation Department, their members, directors, officers, agents, volunteers, and employees harmless from any claim for loss or injury that may be alleged to have been caused directly or indirectly to any person or "thing" by act of other persons, owners, guardians, and/or their dog(s) while in or upon the grounds or near any entrance to Rover's Run and I (we) further agree to hold the aforementioned parties harmless from any claim for loss of our dog(s) by disappearance, theft, damage or injury, be caused or alleged to be caused by the negligence of Greenfield Parks Department or any of the parties aforementioned, or by the negligence of any other person, or any other cause or causes.

I (we) understand that the membership application system is not to establish a guarantee that dogs in the Park are safe or healthy. I (we) also understand that dogs may act unpredictably to their environment. I (we) assume the risk of bodily injuries, including death for any person or persons, including myself (ourselves) arising from the use of Rover's Run. I (we) also will assume the risk of damage to property arising out of consequence of participation at Rover's Run.

I understand that Rover's Run is an unsupervised facility and that no agent or employees of the City of Greenfield or Greenfield Parks Department will supervise the off-leash area at any time and I therefore expressly assume responsibility for all risks associated with the Park as well as fixtures and equipment that may be located there in an unsupervised manner. Furthermore, I (we) will carefully inspect the facilities and satisfy myself (ourselves) that they are safe for their intended use. Once having conducted the inspection, I (we) agree to assume all risks for myself (ourselves), guardians, children, and my (our) dog(s) participating at Rover's Run. I knowingly accept the risks of indigenous plants, mosquitoes, ticks, chiggers, fleas, stray dogs, and wild animals, that may injure or infect both human and dog participants at Rover's Run.

By my (our) signature(s) below, I (we) hereby agree to indemnify and hold harmless the City of Greenfield, The Greenfield Parks and Recreation Department, their members, directors, officers, agents, volunteers, and employees, harmless from any claim or cause of action, judgment, claim for damages by any third party, including but not limited to the payment of any judgment and the incursion of any attorney fees by any of the foregoing entities or individuals, which may arise in any way due to my presence or use of Rover's Run, its grounds, its facilities, or any other aspect of my use of Rover's Run.

By my (our) signature below, I (we) state that I (we): 1-agree to the terms within 2-have received, read and fully understand the Rover's Run Rules and Regulations (and will explain them to any guests who may attend), 3-promise to comply with those rules and regulations and ensure any guests comply as well, and 4-have no knowledge of incidents in which my (our) dogs have shown aggression, fighting, or biting behaviors towards animals or people.

Employee Checklist for Dog Park Applications

- 1-Is the applicant a Greenfield Resident?

Price for Greenfield resident per dog for a collar tag is \$50.00

Price for a non-Greenfield resident per dog for collar tag is \$60.00

NOTE-A collar tag and completed application is required for any registered dog to use the park

The cost of the proximity reader is an additional \$10.00

NOTE-Only one proximity reader is allowed per household-No exceptions

- 2-Has the applicant resented official proof of **REQUIRED** current vaccinations?

Check for the following:

- Name of dog and applicant should be on vaccination records & match application

- Vaccination record dates should be current

(review dates on vet records and verify the due dates for vaccinations to ascertain current status)

- Distemper/Hepatitis/Leptospirosis/Parainfluenza/Parvo (DHLPP)

some young dogs will not have lepto shot b/c of allergies

- Kennel Cough (Bordetella-aka IT or Intratec)

- Rabies

- Make sure all blanks on forms are signed and completed

- Spayed or neutered

- 3-Make sure members are given a flyer, forms packet and a copy of the rules.

Have them read the waivers before signing.

Keep a copy of the signed Rules & Regulations Sheet for Park records.
